Introduction

Description: The European Arrest Warrant (EAW) is the seminal instrument in the field of EU judicial cooperation in criminal matters. It is widely used, and has proven to be an efficient tool in accelerating the execution of warrants and surrender procedures in cross border criminal cases within the EU. At the same time the EAW still poses a number of issues – mostly related to fundamental rights protection - that Member States find difficult to accommodate in their respective legal systems. It is in this context that the seminar is willing to map out the operational success of the EAW and discuss the concerns present in the application of the EAW.

Objectives: The closing conference will provide an overview of the respective national experiences in settling fundamental rights issues in issuing and executing European Arrest Warrants. The added value of the conference is to look at the issues covered by the series of seminars from the national perspective. In this way, all the major themes related the issuing and execution of the European Arrest Warrant, which were discussed from the common European perspective, will be revisited from the particular national point of view. Through highlighting problems and dilemmas surfacing at the national level, an attempt will be made to synthesize the outcome and see how the solutions are offered at the European level wither in the form of harmonized legislation or through the interpretation of such instruments by the Court of Justice of the European Union are received by the national judicial authorities.

The conference style of the event will allow speakers to make short interventions followed by discussion of the panel members facilitated by the EIPA expert. The program will cover the thematic issues regarding the administration of the European Arrest Warrant, which are especially prone to raise fundamental rights concerns.
